### **Terms and Conditions**

1. There is no fee for Customer to enroll in the Apple Heating Oil Budget Plan and Automatic Fill Program. The enrollment deadline is August 31, 2016.
2. The budget year for billing is 11 months, May through March, with any outstanding balances also being due in April.
3. All Customers in Budget Plan must also be enrolled in the Automatic Fill Program and must start the program with a full tank of oil that is paid.
4. Apple Heating Oil will monitor Customer's usage and will schedule delivery amounts and dates at its sole discretion. If Customer anticipates an increase or decrease in consumption based on reasons unknown to Apple Heating Oil (example: home remodeling project), Customer will notify the Apple Heating Oil office.
5. Your budget dollars are to be used for deliveries only. Any other costs incurred must be paid for separately.
6. Apple Heating Oil may make adjustments by raising or lowering Customer's monthly payments under this plan and will notify Customer in writing via mail.
7. Apple Heating Oil may conduct an initial credit check and reserves the right to determine Customer's continued eligibility in Plan throughout the year.
8. Apple Heating Oil will send Customer monthly invoices. Payments will be due by the 15<sup>th</sup> of every month. If Customer is late 10 days, then Customer will be notified in writing of removal from Plan.
9. Apple Heating Oil reserves the right to suspend deliveries for non-payment, acts beyond its control, or if deliveries would endanger personnel, property, or the environment.
10. Apple Heating Oil's heating oil prices do fluctuate and are subject to market conditions and product availability.
11. Customer will automatically be re-enrolled in Budget Plan if no written cancellation is provided. Customer may opt out at any time with a 30-day written notice. The Budget Program is not refundable.
12. Customer is responsible for providing safe access to delivery site in all weather conditions and acknowledges that fuel storage tank is in sound condition and suitable for safe delivery and storage heating oil. Customer shall notify Apple Heating Oil 10 days prior to any changes to the receiving tank or associated piping.
13. In no event will Apple Heating Oil be liable for any special, incidental, consequential, punitive, or indirect damage, whether based on contract, tort (including negligence), indemnity, warranty, strict liability, or otherwise resulting from this agreement shall not exceed one thousand (\$1000) dollars.
14. This offer cannot be combined with any other offer.
15. Cleaning must be scheduled from April 1<sup>st</sup> thru August 31<sup>st</sup>
